### Risk of Loss

Sales of merchandise by FGH to the purchaser are complete upon receipt of payment from the purchaser. The risk of loss and the title to the merchandise pass to the purchaser upon delivery of the merchandise by FGH to the shipping agent.

Fiberglass Hawaii Inc. utilizes UPS Ground shipping for all US Mainland small packages from our Ventura, CA location (93003). Please note that shipping costs are determined by the size and weight of the package as well as the zip code that we are shipping to. Every package shipped from the Ventura warehouse will incur a \$10 handling fee (included in the UPS shipping cost) regardless of the cost of goods. Additionally, a \$35 charge will be added to each regulated quantity HazMat box that is shipped out of our facility (please refer to specific product pages in order to determine whether or not merchandise must ship fully regulated). Fiberglass Hawaii cannot ship hazardous materials via air through UPS to: Alaska, Hawaii, Puerto Rico, Guam, the US Virgin Islands or overseas. Purchaser must call closest location to arrange for alternate shipping. When placing an order for a HazMat item, the purchaser is required to add the "HazMat Shipping Fee" to the shopping cart. If this fee is not added to the cart, merchandise will not ship and the purchaser will be notified by FGH Staff. Every attempt is made to ship out packages on the same day an order has been placed. Orders MUST be received prior to 10am to qualify for same-day shipping (based on merchandise availability).

### Sales Tax

Fiberglass Hawaii Inc. charges sales tax for merchandise ordered on this website based on the applicable state sales tax rate and the location to which the order is being shipped. Purchasers with shipping addresses within the state of California will be charged 7.75% sales tax. # Return Policy

- 1. FGH will accept the return of all merchandise that was damaged or defective at the time it was delivered by FGH to the shipper. Upon receipt of the merchandise and verification of the damage or defect, FGH will refund to purchase the purchase price, the original shipping cost, and the cost of returning the merchandise to FGH.
- 2. FGH will not accept the return of merchandise damaged by the shipper. However, FGH will assist the purchaser in making a claim against the shipper for such damage.
- 3. FGH will accept the return of undamaged, non-defective merchandise, other than cut yardage, books, videos, gel coats, hazardous materials and special order merchandise, provided that the merchandise is returned in resaleable condition. Upon receipt of the merchandise and the determination by FGH, in its sole and absolute

discretion, that the merchandise is re-sellable, FGH will refund to purchaser the purchase price, but not the original shipping cost or return shipping costs.

- 4. FGH may, in its sole and absolute discretion, accept the return of undamaged, non-defective merchandise. If FGH agrees to accept the return of such merchandise, FGH will refund to purchaser the purchase price, less a 15% restocking fee, but will not refund the original or return shipping costs.
- 5. No merchandise, including damaged or defective merchandise, will be accepted for return unless the merchandise and a legible copy of the receipt of payment issued by FGH is delivered, at the purchaser's sole expense, to FGH at 4350 Transport Street, Suite 106, Ventura, CA 93003, within 45 days from the date of sale. The 45 day return period is valid or orders generating from the website only.
- 6. Due to UPS carrier certification requirements for shipment of hazardous materials (HAZMAT) FGH is unable to accept returns of HAZMAT items.
